The Directors of the Company wish to announce that on 10 February 2012 it received written exercise notices for an aggregate of 300,000 ordinary shares in the capital of the Company ("Option Shares") arising from exercise of options granted under the Valuetronics Employee Share Option Scheme. Immediately upon completion of the issue of the New Shares, the number of issued and paid-up capital of the Company has increased from 358,300,000 Shares (excluding treasury shares) to 358,600,000 Shares (excluding treasury shares) and the number of options outstanding has reduced from 13,400,000 to 13,100,000.
