## VALUETRONICS BOOSTS ITS BRAND LICENSING BUSINESS WITH KEY PERSONNEL HIRES

Singapore, 9 September 2010 - Mainboard listed Valuetronics Holdings Limited ("Valuetronics", "鸿通电子控股有限公司" or collectively with its subsidiaries, the "Group"), a premier design, manufacturing and licensing partner for the world's leading brands in the consumer, commercial and industrial electronics sectors, plans to further boost its Licensing Business with the hiring of key personnel.
